# Terms and Conditions

## 1 Acceptance of Terms

- 1.1 By registering for the Aventyr mountain bike event, participants accept these Terms and Conditions, including the Aventyr Rule Book and competition regulations.
- 1.2 This acceptance extends to any third-party registrations. BikeMedia and the event organiser (hereinafter referred to as the "LOC") assume that registrants have the necessary authorisation to register third parties, including underage participants, with the consent of their legal representatives.

## 2 Liability and Insurance

- 2.1 BikeMedia and the LOC do not accept liability for any accidents occurring before, during, or after the event.
- 2.2 Participants are responsible for securing their own accident and liability insurance.

## 3 Registration and Payment

- 3.1 Registration is only possible online.
- 3.2 The registration deadline is two weeks before the event. Late registrations may be accepted at the discretion of BikeMedia for an additional fee of CHF 20.00.
- 3.3 Category changes must be communicated to BikeMedia at least three weeks before the event. Any changes thereafter may incur a CHF 20.00 fee.
- 3.4 On-site registrations are not permitted.
- 3.5 Registration is confirmed only upon full payment, which must be made within 10 days of registration. Unpaid registrations will be cancelled.

## 4 Cancellation and Refunds

- 4.1 Cancellations made up to three weeks before the race are subject to an administration fee of CHF 150.00.
- 4.2 Cancellations within three weeks of the race are non-refundable.
- 4.3 In cases of illness or injury, the same cancellation policy applies.
- 4.4 No refunds will be issued for duplicate registrations made in error.
- 4.5 Participants are encouraged to obtain cancellation insurance.



## 5 **Disqualification and Participant Limits**

- 5.1 BikeMedia and the LOC reserve the right to disqualify participants at any time without refund for false registration details or suspected use of unauthorised substances (e.g., doping).
- 5.2 A participant limit may be set. Registrations exceeding this limit will be placed on a waiting list based on the order of submission.

## 6 **Event Cancellation or Postponement**

- 6.1 If the event is cancelled or partially held due to force majeure, extraordinary risks (including weather conditions), or official orders, no refunds will be issued.
- 6.2 If the event is postponed, standard cancellation terms apply.

## 7 **Data Protection**

By registering, participants agree to the following:

- 7.1 Their personal data may be collected, stored, and processed for event organisation, including by third-party companies.
- 7.2 Data may be shared with third parties for timekeeping, results processing, and publication of start and result lists.
- 7.3 BikeMedia and the LOC may publish participant information in various media formats, including print, online, and TV.
- 7.4 Photographs and video recordings from the event may be used in media and advertising without compensation.
- 7.5 SI Timing GmbH is responsible for timekeeping and administration, and their privacy policy applies: [SI Timing Legal Information](#).
